

Taiwan's Geopolitics

- Historical conflict with China; allied with USA
- Operationally independent, globally "China" or persona non grata
- Courted Chinese diaspora
- New Southbound Policy 2016

Taiwan as an ISM Destination


- Scholarships

Space-making

Imagined, dynamic, relational, powerful (Appadurai, 1999; Massey 2005)


HE Geopolitics (Marginson, 2024):

- mobile spatiality affected
- assumptions of scale & agency (global, regional, national, local)



Space-making (Taiwan)

- Imagined beacon of democracy
- Educational diplomacy
- Fluctuating # of Mainland Chinese students (powerful national politics)
- Targeting SE Asia region (agency)




Power in International Relations (Nye, 2004)
