Second, it seems that for most of the institutions and agencies, there is the co-existence of the two minds – following the current order for their own sustainable development/interests and counter-balancing the global hegemony and inequalities – although to varying degrees. What is your comment of such co-existence, and more specifically, what policy/strategic designs at different levels can encourage and support the exercise of agency?
