01:02:52 David Law: Over 40+ years in HE (in several universities), including being an elected staff member of a GB and being in attendance at GBs, my sense is that whilst there are consistent themes in how GBs operate (dependent on common expectations, consistent context etc) there is great variation in how experienced are members of GBs prior to appointment. Some bring significant experiential learning to the role but others are novices. Does your research suggest that role effectiveness relates to previous experience?

01:07:09 Rob Cuthbert: The long running dispute (now 4 years or so) in the UK about pensions and pay between university employers, the Superannuation Scheme USS and the staff union UCU has been notable for the apparent solidarity and entrenched positions on all sides. Is this the kind of very serious issue where the University Chairs (CUC) should have been more prominent in trying to resolve the dispute? As far as I know they have done no more than offer relatively low-profile support for the employers' position.
